Interpretation (1)

(3CH)

- Introducing the students to basic skills and strategies in simultaneous interpreting from English into Arabic.
- Performing intensive practical training in the interpreting lab on how to handle spoken discourse adequately for interpreting purposes.
- Developing some standard techniques such as hearing, backward oral and written counting while listening, shadowing, echoing and reconstruction of oral messages.
